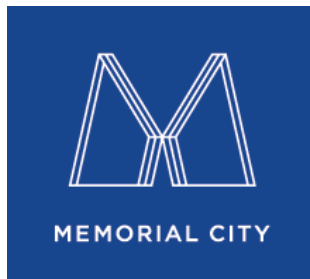

NOTIFICATION: Gift Package Recipients will be notified by social media, email or phone.

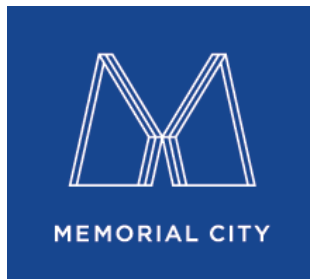
